

RESOLUTION NO. 2015-007

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO ACCEPT AN APPROPRIATION FROM
THE CALIFORNIA OFFICE OF TRAFFIC SAFETY VIA THE SACRAMENTO POLICE
DEPARTMENT TO IMPLEMENT THE AVOID THE 17 DUI PROGRAM IN AN
AMOUNT NOT-TO-EXCEED \$125,740 AND INCREASE THE POLICE
DEPARTMENT'S REVENUE AND EXPENSE BUDGET BY THE ACTUAL AMOUNT
RECEIVED EACH FISCAL YEAR**

WHEREAS, the AVOID Anti-DUI Program provides grant funding to encourage law enforcement agencies to work together on countywide efforts to discourage those who drink and drive; and

WHEREAS, grant funding allows law enforcement agencies within Sacramento County to add overtime hours to conduct enforcement operations as well as public awareness campaigns during peak periods; and


WHEREAS, the Sacramento Police Department is the lead agency for this year's AVOID campaign and has been charged with managing and distributing the grant funds amongst the seventeen (17) participating agencies; and

WHEREAS, the Elk Grove Police Department has agreed to participate in the AVOID Anti-DUI enforcement operations and public awareness campaign by signing a memorandum of understanding with the lead agency, Sacramento Police Department; and

WHEREAS, the safety of Elk Grove citizens is the City Council's primary concern.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to: 1) accept an appropriation from the California Office of Traffic Safety via the Folsom Police Department to implement the AVOID the 17 DUI Program in an amount not to exceed \$125,740; and 2) increase the Police Department's revenue and expense budget by the actual amount received each fiscal year.


