**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AMENDING THE FISCAL YEAR 2014-15 THROUGH FISCAL YEAR 2018-2019
CAPITAL IMPROVEMENT PLAN**

WHEREAS, the City Council has approved the Fiscal Year 2014-15 through Fiscal Year 2018-19 Capital Improvement Program (CIP) and Community Development Block Grant (CDBG) funding allocations for Fiscal Year 2014-15; and


WHEREAS, due to natural delays in Accessibility Improvement Program projects within the CDBG, CDBG funds will not be expended within known time constraints on currently programmed projects; and

WHEREAS, to avoid jeopardizing future CDBG funding, the City must reallocate current CDBG funding to like projects that can utilize the funds within the time lines set by the United States Department of Housing and Urban Development.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby amends FY 2014-2015 through FY 2018-2019 Capital Improvement Plan as follows:




