

RESOLUTION NO. 2015-090

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE CORPORATION YARD EXPANSION PHASE 2 – MATERIALS BIN
STORAGE FACILITY PROJECT AS COMPLETE; AND AUTHORIZING THE CITY
ENGINEER TO PREPARE AND THE CITY CLERK TO FILE THE NOTICE OF
COMPLETION WITH THE SACRAMENTO COUNTY RECORDER**

WHEREAS, on September 10, 2014 the City Council authorized the award of a construction contract to Plummerbuilt, Inc. for the Corporation Yard Expansion Phase 2 – Materials Bin Storage Facility Project (Capital Improvement Project ID WFC003) (the "Project"); and

WHEREAS, the Project constructed a material storage facility consisting of red iron beam construction, masonry walls, and concrete foundation. Additional improvements included asphalt pavement repair, and installation of stationary bollards; and


WHEREAS, Plummerbuilt, Inc. has completed the work in accordance with the terms and conditions of the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Plummerbuilt, Inc.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Corporation Yard Expansion Phase 2 – Materials Bin Storage Facility Project as complete; and

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.
