

RESOLUTION NO. 2015-153

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY ENGINEER OR DESIGNEE TO APPROVE CHANGE
ORDERS NOT-TO-EXCEED \$10,390 FOR THE 9200 MEADOW GROVE
IMPROVEMENTS PROJECT (CEQA EXEMPT)**

WHEREAS, the 9200 Meadow Grove Improvements Project (Project) makes general improvements to correct minor issues with the interior and exterior of the home, as well as rehab and expand the kitchen, and complete electrical, plumbing, and gas work to facilitate the expansion; and

WHEREAS, the Project is included in the City's Community Development Block Grant (CDBG) budget and the approved Fiscal Year 2014-15/2015-16 Budgets; and

WHEREAS, the California Environmental Quality Act (Section 21000 et seq. of the Public Resources Code, herein after CEQA) requires that cities consider the environmental consequences of their actions before approving a project; and

WHEREAS, the Project is a project under CEQA; and

WHEREAS, Section 15301(a) (Existing Facilities) of the State CEQA Guidelines (Chapter 3 of Division 6 of Title 14 of the California Code of Regulations) provides an exemption from CEQA for projects involving the minor alteration of existing public or private facilities when the alteration involves negligible or no expansion of an existing use; and

WHEREAS, an invitation to bid was duly advertised on February 27, 2015, bids were opened on March 31, 2015, and a construction contract was awarded to Sierra Nevada Construction on May 13, 2015; and

WHEREAS, construction work is underway and contemplated change orders will exceed the available authorized construction contract contingency; and

WHEREAS, additional change order authority will be needed to complete the planned work; and

WHEREAS, adequate CDBG funding exists to cover the increase in change order authority needed to complete the Project.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer or designee to approve change orders not-to-exceed \$10,390.


