## **RESOLUTION NO. 2015-183**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE FINDING THE EAST STOCKTON BOULEVARD SIDEWALK EXTENSION TO ELK GROVE PARK PROJECT (WAC006) EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT; AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH SIERRA NATIONAL CONSTRUCTION, INC. FOR THE PROJECT (WAC006) IN THE AMOUNT OF \$203,269; AND AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS NOT-TO-EXCEED \$26,731

WHEREAS, the East Stockton Boulevard Sidewalk Extension to Elk Grove Park Project (WAC006) (the "Project") will construct improved pedestrian access and safety along the eastern side of East Stockton Boulevard to Elk Grove Regional Park's northern driveway, as well as frontage and drainage improvements; and

WHEREAS, the Project is included in the approved Fiscal Year 2015-20 Capital Improvement Program and is budgeted with funds in the approved Fiscal Year 2015-16 Budget; and

WHEREAS, the California Environmental Quality Act (Section 21000 et seq. of the Public Resources Code, hereinafter referred to as CEQA) requires that cities consider the environmental consequences of their actions before approving a project; and

WHEREAS, the Project is a project under CEQA; and

WHEREAS, Section 15301 (Existing Facilities) of the State CEQA Guidelines (Chapter 3 of Division 6 of Title 14 of the California Code of Regulations) provides an exemption from CEQA for projects involving the minor alteration of existing public or private facilities when the alteration involves negligible or no expansion of an existing use; and

WHEREAS, an invitation to bid was duly advertised on July 24, 2015 and July 31, 2015, and bids were opened on August 25, 2015; and

**WHEREAS**, Sierra National Construction, Inc. was determined to be the responsible bidder submitting the lowest responsive bid.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby finds this project exempt from CEQA pursuant to State CEQA Guidelines Section 15301.

<u>Finding</u>: The proposed Project is exempt from CEQA pursuant to section 15301 of the State CEQA Guidelines.

<u>Evidence</u>: The proposed Project is exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities). This exemption applies to the minor alteration of existing public or private facilities when the alteration involves negligible or no expansion of an existing use. The proposed project involves improvements to existing facility to increase pedestrian access and safety along the eastern side of East Stockton Boulevard to Elk Grove Regional Park's northern driveway. This work is minor

in nature in that it does not expand the use beyond its current condition and focuses on repairs and improvements to the structure. No special circumstances exist that would create a reasonable possibility that the Project will have a significant adverse effect on the environment. Therefore, this project qualifies for the identified exemption and no further environmental review is required.

AND BE IT ALSO RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Authorizes the City Manager to execute a construction contract with Sierra National Construction, Inc. for the East Stockton Boulevard Sidewalk Extension to Elk Grove Park Project (WAC006), in the amount of \$203,269 upon receipt of all required bonds and insurance and the approval of such bonds and insurance by the City Attorney; and
- 2) Authorizes the City Engineer to approve change orders not-to-exceed \$26,731.
