

RESOLUTION NO. 2015-230

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO ACCEPT AN APPROPRIATION FROM
THE CALIFORNIA OFFICE OF TRAFFIC SAFETY VIA THE SACRAMENTO POLICE
DEPARTMENT TO IMPLEMENT THE AVOID THE 17 DUI PROGRAM IN AN
AMOUNT NOT-TO-EXCEED 155,160 AND INCREASE THE POLICE
DEPARTMENT'S REVENUE AND EXPENSE BUDGET BY THE ACTUAL AMOUNT
RECEIVED**

WHEREAS, the AVOID Anti-DUI Program provides grant funding to encourage law enforcement agencies to work together on countywide efforts to discourage driving under the influence; and

WHEREAS, grant funding allows law enforcement agencies within Sacramento County to add overtime hours to conduct enforcement operations as well as public awareness campaigns during peak periods; and

WHEREAS, the Sacramento Police Department is the lead agency for this year's AVOID campaign and has been charged with managing and distributing the grant funds among the seventeen (17) participating agencies; and

WHEREAS, each year, the Elk Grove Police Department participates in the AVOID Anti-DUI enforcement operations and public awareness campaign; and

WHEREAS, the safety of Elk Grove citizens is a primary concern of the City Council.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to: 1) accept an appropriation from the California Office of Traffic Safety via the Sacramento Police Department to implement the AVOID the 17 DUI Program in an amount not to exceed \$155,160; 2) execute all contracts, reports, and other documents required for receiving such funds pursuant to the terms and conditions of the grant agency, in a form approved by the City Attorney; and 3) increase the Police Department's revenue and expense budget by the actual amount received.


