

RESOLUTION NO. 2015-170

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO
CONTRACT C-09-157 WITH INFOSEND FOR UTILITY BILLING GOODS AND
SERVICES, AUTHORIZING AN EXPENDITURE OF \$130,000 [FOR A TOTAL
EXPENDITURE OF FUNDS OVER THE CONTRACT TERM NOT-TO-EXCEED
\$1,080,000]**

WHEREAS, InfoSend currently provides the City's traditional billing services as well as e-billing services; and

WHEREAS, the City also contracts with a separate third party for a web based payment solution (e-payment) and staff is researching the best providers to unify the e-billing and e-payment solution; and

WHEREAS, in April of 2013, the City Manager executed a contract amendment with InfoSend, extending the contract term and authorizing additional expenditure of funds considering a reduction for the transfer of e-billing services and;

WHEREAS, the transfer of e-billing services is not complete and InfoSend has continued to provide both traditional billing services and e-billing services.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove authorizes the City Manager to execute an amendment to contract C-09-157 with InfoSend for utility billing goods and services, authorizing an expenditure of \$130,000 [for a total expenditure of funds over the contract term not-to-exceed \$1,080,000].


