

**RESOLUTION NO. 2015-176**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ACCEPTING THE 2014 SLURRY SEAL PROJECT AS COMPLETE; AND  
AUTHORIZING THE CITY ENGINEER TO PREPARE AND THE CITY CLERK TO FILE  
THE NOTICE OF COMPLETION WITH THE SACRAMENTO COUNTY RECORDER**

**WHEREAS**, on October 8, 2014 the City Council authorized the award of a construction contract to VSS International, Inc. for the 2014 Slurry Seal Project (Capital Improvement Project ID WPR008) (the "Project"); and

**WHEREAS**, the Project consisted of slurry sealing, crack sealing, isolated areas of pavement reconstruction, placement of pavement markers, and placement of traffic striping and markings. Additionally, the Project included a seal coat and restriping of the City Hall parking lot; and


**WHEREAS**, VSS International, Inc. has completed the work in accordance with the terms and conditions of the contract documents for the Project; and

**WHEREAS**, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to VSS International, Inc.


