## **RESOLUTION NO. 2016-230**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A THREE-YEAR CONTRACT WITH DOWNTOWN FORD SALES OF SACRAMENTO WITH AN OPTIONAL TWO-YEAR EXTENSION TO SERVICE AND REPAIR CITY OWNED VEHICLES IN AN AMOUNT NOT-TO-EXCEED \$425,000

WHEREAS, the City of Elk Grove's Fleet division maintains City vehicles including mechanical, structural and aesthetic standards; and

WHEREAS, in November of 2016 the City conducted a formal invitation for bid for Ford and General Motors Original Equipment Manufacturer (O.E.M.) Service and Repairs for City owned vehicles. In order to evaluate bids, the City requested Bidders to submit an hourly labor rate, percentage discount from list price for supplying O.E.M. parts, and total cost (including sales tax); and

WHEREAS, the City Clerk received bids from Maita Chevrolet of Elk Grove, Downtown Ford Sales of Sacramento and Elk Grove Ford of Elk Grove; and

WHEREAS, Downtown Ford Sales of Sacramento (Downtown Ford) met all of the formal bid requirements pursuant to Elk Grove Municipal Code Section 3.42.180(a) and therefore was found to be the lowest responsive responsible bidder; and

**WHEREAS**, Fleet Services has sufficient funding identified in its 2016-17 operating budget for this service.

**NOW, THEREFORE BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a three-year contract, in substantially the form presented to the City Council, with Downtown Ford Sales with the option of one additional two-year extension in an amount not-to- exceed \$425,000.
