

RESOLUTION NO. 2017-189

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE FINDING THE CITYWIDE CURB RAMPS 2017 PROJECT (WAC012) EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT AND APPROVING THE PROJECT; AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH SIERRA NATIONAL CONSTRUCTION, INC. FOR THE CITYWIDE CURB RAMPS 2017 PROJECT (WAC012) IN THE AMOUNT OF \$370,035; AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH THE SECOND LOWEST RESPONSIVE BIDDER IF THE FIRST LOWEST RESPONSIVE BIDDER DOES NOT MEET FILING OBLIGATIONS; AND, AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS NOT-TO-EXCEED \$52,800 WITH SIERRA NATIONAL CONSTRUCTION, INC. OR LESSER AMOUNT IF AWARDED TO THE SECOND LOWEST BIDDER.

WHEREAS, the Citywide Curb Ramps 2017 Project (WAC012) (Project) includes removal of accessibility barriers to persons using wheelchairs or other personal assistance devices by reconstructing 42 curb ramps to meet current ADA accessibility requirements (Work); and

WHEREAS, the Project is included in the approved Fiscal Year 2017-22 Capital Improvement Program and is budgeted with funds in the approved Fiscal Year 2017-18 Budget; and

WHEREAS, the Project is a project under California Environmental Quality Act (Section 21000 et seq. of the Public Resources Code, hereinafter referred to as CEQA) which requires that cities consider the environmental consequences of their actions before approving a project; and

WHEREAS, Section 15301 (Existing Facilities) of the State CEQA Guidelines (Chapter 3 of Division 6 of Title 14 of the California Code of Regulations) provides an exemption from CEQA for projects involving the minor alteration of existing public or private facilities when the alteration involves negligible or no expansion of an existing use; and

WHEREAS, an invitation to bid was duly advertised on June 7, 2017 and June 14, 2017, and bids were opened on July 11, 2017; and

WHEREAS, Sierra National Construction, Inc. was determined to be the responsible bidder submitting the lowest responsive bid.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Finds the Project exempt from CEQA pursuant to pursuant to section 15301 of the State CEQA Guidelines and approves the Project; and
- 2) Authorizes the City Manager to execute a construction contract with Sierra National Construction, Inc. for the Citywide Curb Ramps 2017 (WAC012) in the amount of \$370,035 upon receipt of all required bonds and insurance and the approval of such bonds and insurance by the City Attorney; and,

- 3) Authorizes the City Manager to execute a construction contract with the second lowest responsive bidder, FBD Vanguard Construction, Inc., in the amount of \$388,305, if Sierra National Construction, Inc. does not meet filing obligations; and,
- 4) Authorizes the City Engineer to approve change orders not-to-exceed \$52,800 with Sierra National Construction, Inc. if they are awarded the construction contract, or not-to-exceed \$34,528 if the FBD Vanguard Construction, Inc. is awarded the construction contract




