

RESOLUTION NO. 2017-186

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE FORMAL BIDDING REQUIREMENTS PER ELK GROVE MUNICIPAL CODE SECTION 3.42.180(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH PERFORMANCE AUTOMOTIVE GROUP, INC., A CALIFORNIA CORPORATION, DBA ELK GROVE FORD FOR THE PURCHASE OF TWO FISCAL YEAR REPLACEMENT FORD F-150 SUPER CREW PICKUP TRUCKS IN AN AMOUNT NOT-TO-EXCEED \$62,000

WHEREAS, the City of Elk Grove's Fleet division maintains all City vehicles and procures replacements when necessary; and

WHEREAS, the City's Fleet division has identified two vehicles that have reached their useful life of City service and require replacement; and

WHEREAS, the State of California opened a competitive bidding process for the purchase of pickup trucks; and

WHEREAS, Performance Automotive Group Inc., a California Corporation dba Elk Grove Ford (Elk Grove Ford) was awarded State Contract #1-16-23-20F to sell F-150 Super Crew pickup trucks to municipalities; and

WHEREAS, the State of California's large quantity contract award to Elk Grove Ford, which was competitively bid, thus the City is receiving a competitive price; the expenditures of staff time and money to compile the necessary bid documents for a small quantity of vehicles will not likely result in a better price or an outcome more advantageous to the City; and Elk Grove Ford is located within the City of Elk Grove and therefore one percent of every taxable sale will return to the City; and

WHEREAS, for the reasons presented, it is not in the best of interest of the City to conduct formal bidding for the purchase of the subject vehicles; and

WHEREAS, Fleet Services has sufficient funding identified in its 2017-18 fiscal year operating budget for this purchase.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby determines that formal competitive bidding is not in the best interest of the City for the subject vehicles and hereby dispenses with the formal bid requirements pursuant to the Elk Grove Municipal Code Section 3.42.180(B)(3) for a contract for the purchase of the subject vehicles; and

BE IT FURTHER RESOLVED that the City Manager is hereby authorized to execute a contract with Performance Automotive Group, Inc., a California corporation dba Elk Grove Ford for the purchase of two Ford F-150 Super Crew pickup trucks in an amount not-to-exceed \$62,000.


