A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH FURTHER COMPETITIVE BIDDING AND AUTHORIZING THE CITY MANAGER TO EXECUTE AMENDMENT NO. 2: TO CONTRACT C-14-063 WITH BONG GOO LEE CORPORATION FOR ALTERATION SERVICE OF POLICE UNIFORMS IN THE AMOUNT OF \$6,000 FOR A TOTAL CONTRACT NOT-TO-EXCEED AMOUNT OF \$72,000 THROUGH FEBRUARY 28, 2018

WHEREAS, the Elk Grove Police Department has 141 sworn officer positions which mandate uniform attire; and

WHEREAS, police uniforms require sewn on patches, chevrons, service stripes, and occasional alterations; and

WHEREAS, staff conducted a competitive bid process in 2013-2014 to find a uniform alterations provider that offered the most competitive prices; and

WHEREAS, Moonlight Cleaners offered the most competitive pricing and proven quality service in response to the request for proposals and was awarded the contract; and

WHEREAS, Bong Goo Lee Corporation assumed the Moonlight Cleaners contract with the City's consent; and

WHEREAS, staff proposes to amend the Bong Goo Lee Corporation contract amount to accommodate additional City staff; and

WHEREAS, for the reasons presented, soliciting competitive bids for the services provided by the contract amendment is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with further competitive bidding and authorizes the City Manager to execute Amendment No. 2 to contract C-14-063 with Bong Goo Lee Corporation for uniform alterations service of police uniforms in the amount of \$6,000 for a total contract not-to-exceed amount of \$72,000 through February 28, 2018.
