

RESOLUTION NO. 2018-022

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO ACCEPT AN APPROPRIATION FROM
THE STATE SUPPLEMENTAL LAW ENFORCEMENT SERVICES FUND IN THE
AMOUNT OF \$261,721 TO BE USED TO CREATE TWO NEW FULL-TIME
PERMANENT POSITIONS: ONE CRIME ANALYST AND ONE DISPATCH
SUPERVISOR**

WHEREAS, the State Legislature has authorized the release of supplemental funding under the State Supplemental Law Enforcement Services Fund (SLESF) for FY 2017-18; and

WHEREAS, the amount appropriated for the Elk Grove Police Department is \$261,721 for a two year period; and

WHEREAS, funds under this program must be used in accordance with Government Code 30061; and

WHEREAS, the Police Department contracted with the Professional Development Institute for a comprehensive police staffing assessment which recommended the addition of a crime analyst and dispatch supervisor; and

WHEREAS, the Police Department has determined to use the SLESF funds to create two new full-time permanent positions of crime analyst and dispatch supervisor.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to 1) accept an appropriation from the State Supplemental Law Enforcement Services Fund (SLESF) in the amount of \$261,721; 2) increase the Police Department's revenue and expense budget in the amount of \$261,721; and 3) expend funds in accordance with Government Code Section 30061 mandating that these funds be used for police services, in the creation of two new full-time permanent positions: crime analyst and dispatch supervisor


