

RESOLUTION NO. 2018-037

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH SIRCHIE ACQUISITION COMPANY, LLC, FOR THE PURCHASE OF THREE SOLAR POWERED SURVEILLANCE TRAILERS WITH TELESCOPING MASTS IN AN AMOUNT NOT-TO-EXCEED \$90,000 AND AUTHORIZING THE CITY FACILITY AND FLEET MANAGER TO APPROVE CHANGE ORDERS NOT-TO-EXCEED \$9,000**

**WHEREAS**, mobile surveillance trailers are a necessary resource for the Police Department; and

**WHEREAS**, in November of 2017, the City announced a formal Invitation to Bid (ITB) for three solar powered surveillance trailers with telescoping masts; and

**WHEREAS**, Sirchie Acquisition Company, LLC, met all of the requirements of the ITB, and therefore was found to be the lowest responsive responsible bidder; and

**WHEREAS**, the Police Department has sufficient funding identified in its 2017-18 Fiscal Year operating budget for this purchase.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a contract in substantially the form presented with Sirchie Acquisition Company LLC to purchase three solar powered surveillance trailers with telescoping masts for the Police Department in an amount not-to-exceed \$90,000, and authorizing the City Facility and Fleet Manager to approve change orders not-to-exceed \$9,000.


