**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH THE COMPETITIVE PROPOSAL PROCESS PURSUANT TO
ELK GROVE MUNICIPAL CODE CHAPTER 3.42, AND AUTHORIZING THE CITY
MANAGER TO EXECUTE A CONTRACT WITH JACK CLANCY ASSOCIATES FOR
PROMOTIONAL EXAMINATION AND SELECTION ASSESSMENT SERVICES FOR
FIVE YEARS IN AN AMOUNT NOT-TO-EXCEED \$150,000**


WHEREAS, the City of Elk Grove believes in offering promotional opportunities to its staff and understands the need for a qualified examination process and professional assessment center for promotional positions; and

WHEREAS, the City has contracted with Jack Clancy Associates for Police Department promotional examinations for several years, and Jack Clancy Associates has demonstrated a high level of competence and excellent service to the City in establishing the examination process and assessment center; and

WHEREAS, the City Council determines that with the institutional knowledge and specialization in promotional examinations and selection assessment services possessed by Jack Clancy Associates, and other reasons presented by City staff, seeking competitive proposals for the subject services is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the competitive proposal process pursuant to Elk Grove Municipal Code section 3.42.140(B)(3), and authorizes the City Manager to execute a contract with Jack Clancy Associates, in substantially the form presented, for five years in an amount not-to-exceed \$150,000.




