A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH COMPETITIVE BIDE/ING AND AUTHORIZING THE CITY MANAGER TO EXECUTE AMENDMENT NO. 2 TO CONTRACT C-13-380 WITH MIWALL CORPORATION FOR THE SUPPLY OF AMMUNITION FOR THE ELK GROVE POLICE DEPARTMENT IN THE AMOUNT OF \$210,000 FOR A TOTAL CONTRACT NOT-TO-EXCEED AMOUNT OF \$562,000 THROUGH JUNE 30, 2021

WHEREAS, the Elk Grove Police Department has 141 sworn officer positions authorized which require a firearm; and

WHEREAS, regular firearms training is required to maintain shooting proficiency and safety; and

WHEREAS, the Elk Grove Police Department must maintain a supply of ammunition for officer training, qualification, and duty; and

WHEREAS, in June 2013 staff conducted a competitive bid process to find an ammunition supplier that offered the best pricing and awarded a contract with Miwall Corporation; and

WHEREAS, Miwall Corporation is the sole provider of Hornady Law Enforcement ammunition in the state of California, which is the preferred ammunition of the Elk Grove Police Department; and

WHEREAS, Miwall Corporation is a local corporation that has demonstrated its ability to provide specialty ammunition without delay, provides training ammunition at half off, and maintains consistently low prices; and

WHEREAS, for the reasons presented, pursuit of competitive bidding for the purchase of the ammunition is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with competitive bidding for the propose ammunition purchase, and authorizes the City Manager to execute Amendment No. 2 to contract C-13-380 with Miwall Corporation, in substantially the form presented, for the supply of ammunition for the Elk Grove Police Department in the amount of \$210,000 for a total contract not-to-exceed amount of \$562,000 through June 30, 2021.
