**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO ENTER INTO A MEMORANDUM OF
UNDERSTANDING AND COOPERATIVE AGREEMENT WITH THE CAPITAL
REGION SMALL BUSINESS DEVELOPMENT CENTER TO ESTABLISH A SOUTH
SACRAMENTO COUNTY SMALL BUSINESS DEVELOPMENT CENTER
AT ELK GROVE CITY HALL**

WHEREAS, the goals of the Elk Grove City Council include fostering a vibrant and diverse economy oriented toward growing jobs, which includes supporting small businesses and entrepreneurs and regional collaboration; and


WHEREAS, the City of Elk Grove supports its small businesses and the City of Elk Grove seeks to provide small business support services to assist entrepreneurs in starting a new business or in expanding their existing business; and

WHEREAS, in furtherance of the City's small business goals, the City of Elk Grove and the Capital Region Small Business Development Center wish to partner to provide for the establishment of a south Sacramento County Small Business Development Center at Elk Grove City Hall; and

WHEREAS, the City of Elk Grove has determined that the Capital Region Small Business Development Center is the sole entity for providing Small Business Development Center services funded by the Small Business Administration in the Greater Sacramento Region.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove finds that entering into the Cooperative Agreement as proposed is in the best interest of the City and authorizes the City Manager to enter into a Memorandum of Understanding and Cooperative Agreement with the Capital Region Small Business Development Center, in substantially the form presented, to establish a south Sacramento County Small Business Development Center at Elk Grove City Hall.




