**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE THE FIRST AMENDMENT TO  
THE SOLID WASTE COLLECTION SERVICES FRANCHISE AGREEMENT  
BETWEEN THE CITY OF ELK GROVE AND ALLIED WASTE SERVICES OF NORTH  
AMERICA, LLC. (REPUBLIC SERVICES, INC.)**

**WHEREAS**, the City of Elk Grove entered into an agreement with Allied Waste Services of North America, LLC ("Republic Services") Franchise Agreement C-17-149 ("Franchise Agreement"); and

**WHEREAS**, the Franchise Agreement commences on July 1, 2018; and


**WHEREAS**, all identified current and future City-owned public refuse and recycling containers will be serviced by Republic Services; and

**WHEREAS**, the Consumer Price Index (CPI) used to calculate all rate and cost increases related to this Franchise Agreement will now be named "San Francisco-Oakland-Hayward" to match the geographic sample boundary drawn by the Bureau of Labor Statistics; and

**WHEREAS**, the First Amendment to the Franchise Agreement includes the continuation of all programs as outlined in the current Franchise Agreement, renames the applicable CPI, and includes additional service locations on public streets with high foot traffic.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove authorizes the City Manager to execute a First Amendment to the Solid Waste Collection Services Franchise Agreement between the City of Elk Grove and Allied Waste Services of North America, LLC (Republic Services, Inc.) in substantially the form presented.




