## RESOLUTION NO. 2018-094

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE STANDARD REQUEST FOR PROPOSAL PROCESS PURSUANT TO ELK GROVE MUNICIPAL CODE 3.42.140(B)(3) AND ALLOWING FOR A REQUEST FOR QUALIFICATIONS / REQUEST FOR PROPOSAL PROCESS FOR PUBLIC ART PROJECTS

**WHEREAS**, the City Council adopted Resolution No. 2016-226 to implement the Percent for the Arts Program (Art Program) for art in publically funded facilities and parks (Public Art); and

**WHEREAS**, a specific selection process for the artists / pieces was not established when the Art Program was adopted; and

WHEREAS, for selection of Public Art under the Art Program, staff recommends the use of a Request for Qualifications (RFQ) process to solicit a wide range of applicants / artists, followed by a focused and informal Request for Proposal (RFP) process of the selected qualified artists, compensating this selected group of artists for proposals, all with the intent to secure the best proposal for the City for Public Art; and

WHEREAS, for the reasons presented, use of the standard RFP process, as set forth in the Elk Grove Municipal Code section 3.42.140(B)(3) for soliciting and contracting for Public Art is not in the best interest of the City; and

**WHEREAS**, the purpose of this resolution is to provide for an alternative and optional process for the solicitation and contracting for Public Art within the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby approves an alternative and optional process for the solicitation and contracting for Public Art within the City, to be used at the City Manager's discretion, dispensing with the standard RFP process pursuant to EGMC section 3.42.140(B)(3) and allowing for an RFQ process, followed by a focused and informal RFP process of qualified artists, and authorizing the City Manager to expend not more than \$1,500 per art proposal to compensate a selected and qualified artist from whom a proposal is sought in order to reimburse the artist for the cost of preparation of the proposal.
