A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE FINDING THE LEFT TURN LANE EXTENSION WESTBOUND LAGUNA BOULEVARD AT LAGUNA PARK DRIVE (EAST) (WTC012) AND LEFT TURN POCKET EXTENSION EASTBOUND LAGUNA BOULEVARD AT FRANKLIN **BOULEVARD (WTC013) PROJECTS EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT AND APPROVING THE PROJECTS:** AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH WESTERN ENGINEERING CONTRACTORS IN THE AMOUNT OF \$503,579; AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS NOT-TO-EXCEED \$75,500; AMENDING THE FY 2017-22 CAPITAL IMPROVEMENT PROGRAM AND FISCAL YEAR 2017-18 BUIDGET FOR THE LEFT TURN POCKET EXTENSION EASTBOUND LAGUNA BOULEVARD AT FRANKLIN BOULEVARD (WTC013) ADDING \$29,000 IN GAS TAX (FUND 221) FUNDS; AND AUTHORIZING THE CITY MANAGER TO REJECT ALL BIDS AND RE-BID THE PROJECTS IN THE EVENT WESTERN ENGINEERING CONTRACTORS FAILS TO TIMELY EXECUTE THE CONTRACT DOCUMENTS

WHEREAS, the Left Turn Lane Extension Westbound Laguna Boulevard at Laguna Park Drive (East) (WTC012) and Left Turn Pocket, Extension Eastbound Laguna Boulevard at Franklin Boulevard (WTC013) (Projects) improve traffic flow through the through lanes on Laguna Boulevard at existing left turn lanes; and

WHEREAS, the Left Turn Lane Extension Westbound, Laguna Boulevard at Laguna Park Drive (EAST) Project (WTC012) will extend the existing westbound left turn lane along Laguna Boulevard at Laguna Park Drive (East) to help improve traffic flow along westbound through lanes; and

WHEREAS, the Left Turn Pocket Extension Eastbound Laguna Boulevard at Franklin Boulevard Project (WTC013) will extend the existing eastbound left turn pocket along Laguna Boulevard to northbound Franklin Boulevard to help improve traffic flow along eastbound through lanes, and will also provide Bike Route signage for cyclists traveling eastbound on Laguna Boulevard to avoid crossing at the Franklin Boulevard intersection; and

WHEREAS, the Projects are included in the approved Fiscal Year 2017-22 Capital Improvement Program and are budgeted with funds in the approved Fiscal Year 2017-18 Budget; and

WHEREAS, the Projects are a project under California Environmental Quality Act (Section 21000 et seq. of the Public Resources Code, hereinafter referred to as CEQA) which requires that cities consider the environmental consequences of their actions before approving a project; and

WHEREAS, Section 15301(c) (Class I: Existing Facilities) of the State CEQA Guidelines (Chapter 3 of Division 6 of Title 14 of the California Code of Regulations) provides an exemption from CEQA for projects involving the minor alteration of existing public or private facilities when the alteration involves negligible or no expansion of an existing use; and

WHEREAS, an invitation to bid was duly advertised on April 25, 2018 and May 2, 2018, and bids were opened on May 17, 2018; and

WHEREAS, Western Engineering Contractors was determined to be the responsible bidder submitting the lowest responsive bid.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Finds the Projects exempt from CEQA pursuant to section 15301(c) of the State CEQA Guidelines and approves the Projects; and
- 2) Authorizes the City Manager to execute a construction contract with Western Engineering Contractors for the Left Turn Lane Extension Westbound Laguna Boulevard at Laguna Park Drive (East) (WTC012) and Left Turn Pocket Extension Eastbound Laguna Boulevard at Franklin Boulevard (WTC013) Projects in the amount of \$503,579 upon receipt of all required bonds and insurance and the approval of such bonds and insurance by the City Attorney; and
- 3) Authorizes the City Engineer to approve change orders not-to-exceed \$75;500; and
- 4) Amends the FY 2017-22 Capital Improvement Program and Fiscal Year 2017-18 Budget for the Left Turn Pocket Extension Eastbound Laguna Boulevard at Franklin Boulevard Project (WTC013)) adding \$29,000 in Gas Tax (Fund 221) funds; and
- 5) Authorizes the City Manager to reject all bids and re-bid the Projects in the event Western Engineering Contractors fails to timely execute the contract documents.
