

RESOLUTION NO. 2018-110

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO ACCEPT GRANT FUNDING FROM THE
CALIFORNIA DEPARTMENT OF ALCOHOLIC BEVERAGE CONTROL IN THE
AMOUNT OF \$49,258 AND AMEND THE POLICE DEPARTMENT'S BUDGET IN THE
SAME AMOUNT FOR THE PURPOSE OF IMPLEMENTING STRATEGIES TO
REDUCE UNDERAGE DRINKING IN ELK GROVE**

WHEREAS, in January 2018, the Department of Alcoholic Beverage Control announced funding opportunities for local law enforcement agencies interested in implementing programs that would allow them to expand their enforcement efforts in addressing underage alcohol use; and

WHEREAS, the Elk Grove Police Department submitted a grant proposal that included strategies such as Minor Decoy and Shoulder Tap operations that would target various retail outlets that engage in the illegal sale of alcoholic beverages to minors; and

WHEREAS, Minor Decoy and Shoulder Tap operations are proven law enforcement methods that reduce minors' access to alcohol; and


WHEREAS, the safety of Elk Grove citizens is the Police Department's primary concern; and

WHEREAS, this grant supports City Council's goal to foster and support safe communities.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby adopts a resolution authorizing the City Manager to:

- 1) Accept grant funding from the California Department of Alcoholic Beverage Control in the amount of \$49,258 for the purpose of implementing strategies to reduce underage drinking in Elk Grove; and
- 2) Execute all related documents required for receiving \$49,258 pursuant to the terms and conditions of the California Department of Alcoholic Beverage Control; and
- 3) Amend the Police Department's revenue and expense budget each fiscal year until the total amount of \$49,258 is expended.




