

RESOLUTION NO. 2018-158

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO APPLY FOR FY 2018 FTA SECTION 5339 BUS AND BUS FACILITIES INFRASTRUCTURE INVESTMENT PROGRAM FUNDS, FOR THE PURCHASE OF TWO 40' CNG REPLACEMENT VEHICLES, IN THE AMOUNT OF \$1,020,000, AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL REQUIRED DOCUMENTS FOR THE RECEIPT AND ADMINISTRATION OF THESE FUNDS

WHEREAS, the City of Elk Grove is an eligible project sponsor and may receive FTA Section 5339 Bus and Bus Facilities Infrastructure Investment Program Funds, now or sometime in the future for transit projects; and

WHEREAS, the funding program is competitive, and the City is not guaranteed award of this Federal funding if applied for; and


WHEREAS, the maximum Federal share of funding that can be awarded to an eligible project is 85% of the net project cost and will require a local match of 15%, which will be provided with State Transit Assistance (STA) funds; and

WHEREAS, purchasing these buses will support the maintenance of the City's local and commuter fixed-route transit system in a state of good repair, and ensure that the fleet can maintain a healthy spare ratio of 20% to minimize disruption in service.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to apply for FY2018 FTA Section 5339 Bus and Bus Facilities Infrastructure Investment Program funds, in the amount of \$1,020,000, and to utilize STA funds in the amount of \$180,000 for the 15% local match required by the funding program, if Federal funding is awarded.

AND BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute all required documents for the receipt and administration of these funds, if awarded.


