DISPENSING WITH THE COMPETITIVE BIDDING PROCESS PURSUANT TO EGMC

AMENDMENT TO THE CONTRACT WITH OCCU-MED, LTD. FOR PREEMPLOYMENT MEDICAL EXAMS IN THE AMOUNT OF \$42,000 FOR A TOTAL
CONTRACT NOT-TO-EXCEED AMOUNT OF \$97,000 THROUGH MARCH 31, 2022

WHEREAS, the Elk Grove Police Department requires pre-employment medical evaluations for candidates who have received a conditional offer of employment; and

WHEREAS, pre-employment medical evaluations help to determine if a candidate is safely able to perform essential job functions with or without accommodation; and

WHEREAS, Occu-Med, Ltd. provides the highly specialized service of preemployment medical evaluations; and

WHEREAS, Occu-Med, Ltd. is a national leader in medical evaluations for employment and is known for producing thorough evaluations that are legally defensible, meet state and federal regulations, and are delivered promptly; and

WHEREAS, for the reasons presented, pursuing a formal request for proposal process for the requested services is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the competitive bidding process pursuant to EGMC 3.42.140(B)(3) and authorizes the City Manager to execute a ninth amendment to the contract with Occu-Med, Ltd., in substantially the form presented, for pre-employment medical exams in the amount of \$42,000 for a total contract not-to-exceed amount of \$97,000 through March 31, 2022.
