## **RESOLUTION NO. 2018-209**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH COMPETITIVE PROPOSALS PURSUANT TO ELK GROVE MUNICIPAL CODE 3.42.140(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE AMENDMENTS TO THE CONTRACTS WITH KITTEL FAMILY VETERINARY PRACTICE AND VCA ANIMAL HOSPITAL, INC. ESTABLISHING A PRICE LIST WITH MAXIMUM ALLOWANCES AND EXTENDING THE CONTRACT TERMINATION DATE TO MARCH 31, 2020

**WHEREAS**, the Elk Grove Police Department Animal Control unit provides services for lost and stray animals to ensure the safety and well-being of animals and people in the City, and

WHEREAS, the City contracts with local veterinary hospitals to provide a variety of health services to lost, injured, or sick animals found roaming the City; and

**WHEREAS**, the City is in the process of building an animal shelter, complete with its own on-site veterinarian, to be completed in spring 2019; and

**WHEREAS**, the veterinarian at the City Animal Shelter will provide many services currently provided by locally contracted veterinary hospitals; and

WHEREAS, it is unknown at this time to what extent the veterinarian at the City Animal Shelter will supplant the services currently contracted with local veterinary offices; and

WHEREAS, establishing a price list and identifying maximum allowances will ensure prices remain constant throughout the contract extension; and

WHEREAS, for the reasons presented, pursuing a formal request for proposal process for the requested veterinary services is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the competitive proposal process pursuant to Elk Grove Municipal Code 3.42.140(B)(3) and authorizes the City Manager to execute amendments to the contracts with Kittel Family Veterinary Practice and VCA Animal Hospitals, Inc., in substantially the form presented, establishing a price list with maximum allowances and extending the contract termination date to March 31, 2020.
