

RESOLUTION NO. 2018-225

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
APPROVING THE CREATION OF THE ELK GROVE ARTS COMMISSION ANNUAL
AWARDS**

WHEREAS, the City Council adopted Resolution No. 2002-108 to create the Elk Grove Committee for the Arts to recognize the importance of arts and culture in the community, and has taken various actions since that time to enhance the Committee's role in promoting the arts locally and to change the name of the Committee to the City of Elk Grove Arts Commission; and

WHEREAS, members of the Arts Commission are active advocates for arts in the community, and have been integral in the establishment of the Percentage for the Arts program and the selection of artwork at public facilities; and

WHEREAS, to recognize and celebrate local artists, the Commission has proposed an annual awards program that would recognize achievements by local artists in the categories of Visual Arts, Performing Arts, Literary Arts, Patron of the Arts, and a Lifetime Achievement Award; and

WHEREAS, the Commission has proposed criteria for the awards including residency within the City of Elk Grove or Elk Grove Unified School District for five or more years; nominees must be arts professionals with a body of work; have mentored up and coming artists in their field; and volunteered their talents in the community without charge; and

WHEREAS, the Commission would like to name the award the "Iris" to recognize the contributions of the late Iris Zimbelman who created the Strauss Festival; and

WHEREAS, the purpose of this resolution is to create a recognition program for local artists by the Elk Grove Arts Commission.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby approves creation of the Elk Grove Arts Commission Annual Awards as described above.




