

RESOLUTION NO. 2019-048

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE COMPETITIVE PROPOSAL PROCESS PURSUANT TO EGMC 3.42.188(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE AMENDMENT NO. 3 TO THE CONTRACT WITH BONG GOO LEE CORPORATION (CONTRACT #C-16-078) FOR DRY CLEANING SERVICES FOR POLICE UNIFORMS IN THE AMOUNT OF \$105,000 FOR A TOTAL CONTRACT NOT-TO-EXCEED AMOUNT OF \$185,000 THROUGH APRIL 30, 2022

WHEREAS, the Elk Grove Police Department has 146 sworn officer positions which mandate uniform attire; and

WHEREAS, police uniforms require dry cleaning for proper care; and

WHEREAS, staff conducted a competitive bid process in 2016 to identify a dry cleaning service provider that offered the most competitive prices; and

WHEREAS, Moonlight Cleaners offered the most competitive pricing and proven quality service; and

WHEREAS, Bong Goo Lee purchased Moonlight Cleaners, assuming their rights and obligations under the original contract; and

WHEREAS, Bong Goo Lee has agreed to continue providing service to the City at the same pricing and terms found in the original agreement; and

WHEREAS, for the reasons presented, pursuing a formal competitive proposal process for the dry cleaning services addressed by the proposed amended contract is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby adopts a resolution dispensing with the competitive proposal process pursuant to EGMC 3.42.188(B)(3) and authorizing the City Manager to execute Amendment No. 3 to contract #C-16-078 with Bong Goo Lee Corporation for dry cleaning services for police uniforms in the amount of \$105,000 for a total contract not-to-exceed amount of \$185,000 through April 30, 2022.




