

RESOLUTION NO. 2019-096

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH THE COMPETITIVE BIDDING PROCEDURE PURSUANT TO
ELK GROVE MUNICIPAL CODE SECTION 3.42.180(B)(3) AND AUTHORIZING THE
CITY MANAGER TO EXECUTE A THREE-YEAR CONTRACT WITH SOLUTIONS
FOR TRANSIT FOR GFI REPORTING SERVICES, IN AN AMOUNT NOT-TO-
EXCEED \$135,000

WHEREAS, Solutions for Transit has been providing reporting services to the City that includes database modules and GFI farebox data reports, which are generated from ridership and fare information collected on each bus that assist City staff with managing daily transit services and operations through an existing contract, ending June 30, 2019, and

WHEREAS, Solutions for Transit provides several monthly services that include: Information Technology support, analysis and oversight of all data entered and reported to the City by MV Transportation (the City's contract operator), GFI support, and support to City staff on various transit related issues; and

WHEREAS, City staff wants to continue all existing services provided under the existing contract; and

WHEREAS, additional services are required by Solutions for Transit to integrate the City's smart card data system, known as Connect Card, and the City's Automated Passenger Counting system, with the GFI farebox data for consistent reporting; and

WHEREAS, for the reasons presented, compliance with the competitive bidding procedures is not in the best interest of the City for the subject services.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the competitive bidding procedures pursuant to Elk Grove Municipal Code Section 3.42.180(B)(3) and authorizes the City Manager to execute a contract with Solutions for Transit for the GFI Reporting Project, for a total contract compensation amount not-to-exceed \$135,000.




