

RESOLUTION NO. 2019-097

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AMENDING THE 2018-2023 CAPITAL IMPROVEMENT PROGRAM PROJECT DESCRIPTION FOR THE ELK GROVE AND LAGUNA BOULEVARDS UPRR XING INTERIM BIKE LANE IMPROVEMENTS PROJECT (WAM002); FINDING THE PROJECT EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT AND APPROVING THE PROJECT; AND AUTHORIZING AN INCREASE TO THE CHANGE ORDER AUTHORITY FOR THE PROJECT BY \$23,000

WHEREAS, the Elk Grove and Laguna Boulevards UPRR Xing Interim Bike Lane Improvements Project (WAM002) (Project) includes improved safety for cyclists through the installation of green bike lane pavement markings along the existing Class 2 bicycle lane in both directions along Elk Grove Boulevard and Laguna Boulevard at the Union Pacific Railroad Overcrossing, including minor modifications to curbs and gutters to accommodate additional width for the Class 2 bicycle lanes; and

WHEREAS, the Project is located at Elk Grove Boulevard between Four Winds Drive and Franklin Boulevard, and at Laguna Boulevard between Babson Drive and Santorini Drive; and

WHEREAS, the project was originally awarded by City Council on April 24, 2019; and

WHEREAS, the Trails Committee presented its Annual Update on April 24, 2019 and requested that green bike lane pavement markings be placed along the existing Class 2 bicycle lanes in both directions of East Stockton from the northbound State Route 99 Ramps to Elk Grove Boulevard; and

WHEREAS, Staff has reviewed the requested scope of work proposed by the Trails Committee and has determined that it is a feasible change, would improve safety for cyclists, and could be easily added to the Elk Grove and Laguna Boulevards UPRR XING Interim Bike Lane Improvements Project (WAM002); and

WHEREAS, the Project is a project under California Environmental Quality Act (Section 21000 et seq. of the Public Resources Code, hereinafter referred to as CEQA) which requires that cities consider the environmental consequences of their actions before approving a project; and

WHEREAS, the Project was previously determined exempt under CEQA Categorical Exemption 15301(c) (Class 1: Existing Facilities) and approved by City Council on April 24, 2019. The Notice of Exemption was filed with the Sacramento County Clerk on May 3, 2019. After the Project was approved by City Council, the Project was subsequently expanded in scope to add additional green bike lane pavement marking within the existing Class 2 bicycle lanes in both directions along East Stockton between the North Bound State Route 99 Ramps and Elk Grove Boulevard. As this additional work consists of pavement markings to existing City infrastructure within existing right-of-way and would not involve any expansion of use, it is the type of activity consistent with those allowed under CEQA Categorical Exemption 15301(c) (Class I: Existing Facilities). No further environmental review under CEQA is required; and

WHEREAS, the Project is included in the approved Fiscal Year 2018-23 Capital Improvement Program and is budgeted with funds in the approved Fiscal Year 2018-19 Budget; and

WHEREAS, the estimated project cost is equal to the total available budget.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Amends the 2018-2023 Capital Improvement Program project description for the Elk Grove and Laguna Boulevards UPRR XING Interim Bike Lane Improvements Project (WAM002) by adding the following text: The projects will also install green bike lane pavement markings along the existing Class 2 bicycle lanes in both directions of East Stockton Boulevard from the northbound State Route 99 Ramps to Elk Grove Boulevard;and
- 2) Finds the Project exempt from CEQA pursuant to section 15301 of the State CEQA Guidelines and approves the Project; and
- 3) Authorizes an increase to the change order authority for the Project by \$23,000.




