**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DESIGNATING COSUMNES COMMUNITY SERVICES DISTRICT FIRE
DEPARTMENT STAFF AS CODE ENFORCEMENT OFFICERS IN THE CITY
OF ELK GROVE FOR PURPOSES OF ENFORCEMENT OF CHAPTER 17.06
(FIREWORKS VIOLATIONS)**

WHEREAS, Elk Grove Municipal Code (EGMC) Chapter 17.06 contains City regulations and enforcement authority concerning unlawful use of fireworks within the City; and

WHEREAS, EGMC Section 17.06.010(D) defines "Code Enforcement Officer" to include "any employee or agent of the City of Elk Grove designated by the City Council" to enforce Chapter 17.06; and

WHEREAS, EGMC Section 17.06.030 authorizes administrative citations to be issued for fireworks violations under EGMC Chapter 17.06; and

WHEREAS, the Cosumnes Community Services District Fire Department (CCSDFD) partners with the City of Elk Grove during the Fourth of July holiday celebrations in enforcing fireworks violations by providing firefighters and fire prevention officers to assist with enforcement.

NOW, THEREFORE, BE IT RESOLVED that, as of the date of this resolution through and including July 31, 2019, the City Council of the City of Elk Grove hereby designates the Chief of the CCSDFD and his or her designees as Code Enforcement Officers of the City of Elk Grove for the purposes of enforcing fireworks violations under EGMC Chapter 17.04, including the authority to issue administrative citations for violations.
