

RESOLUTION NO. 2019-121

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A THREE-YEAR AGREEMENT
WITH ONE OPTIONAL THREE-YEAR EXTENSION WITH D-TAC K9, LLC FOR
POLICE CANINE TRAINING SERVICES IN AN AMOUNT NOT-TO-EXCEED \$252,000**

WHEREAS, the Elk Grove Police Department has a Canine Unit made up of six police canines and their police officer handlers; and

WHEREAS, the Canine Unit assists with criminal apprehension, narcotics detection, firearms detection, locating missing persons, and providing public demonstrations; and

WHEREAS, this type of work requires on-going professional training provided by individuals with extensive police canine expertise; and

WHEREAS, staff publicly announced a Request for Proposals (RFP) seeking service providers of police canine training services that would offer the City of Elk Grove competitive contract pricing and quality service; and

WHEREAS, D-TAC K9, LLC was the only respondent to the City's RFP process; and

WHEREAS, the owner and primary trainer for D-TAC K9, LLC has extensive police canine handling and training experience and is highly recommended by the law enforcement agencies he currently serves; and

WHEREAS, staff determined D-TAC K9, LLC is able to provide the services requested in the RFP at competitive pricing.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a three-year agreement with one optional three-year extension with D-TAC K9, LLC, in substantially the form presented, for police canine training services in an amount not-to-exceed \$252,000.
