**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH ELK
GROVE UNIFIED SCHOOL DISTRICT TO PROVIDE TEMPORARY AND PART-TIME
SERVICES FROM UNIFORMED ELK GROVE POLICE DEPARTMENT OFFICERS
WORKING OVERTIME**

WHEREAS, the Elk Grove Police Department provides contracted, uniformed, overtime police officers for establishments and special events; and

WHEREAS, Elk Grove Unified School District has requested contracted, uniformed Elk Grove Police Department officers working overtime, to perform law enforcement duties at Elk Grove Unified School District locations and events; and

WHEREAS, the contracted, uniformed police officers provide security, crowd control, and other details which do not fall within the scope of a patrol officer's normal responsibilities; and

WHEREAS, the rate charged for this service to the Elk Grove Unified School District shall be based on the average overtime rate for an Elk Grove Police Department Officer; and

WHEREAS, contracted, uniformed police officers create a positive relationship between businesses, the Elk Grove Police Department, and the public.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to enter into contract with Elk Grove Unified School District, in substantially the form presented, to provide temporary and part-time services from uniformed Elk Grove Police Department officers working overtime.
