

RESOLUTION NO. 2019-178

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE FINDING THE FY20 CITYWIDE CRACK SEAL PROJECT (OM2001) EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT AND APPROVING THE PROJECT; AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH GLOBAL ROAD SEALING, INC. FOR THE PROJECT IN THE AMOUNT OF \$603,342; AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS NOT-TO-EXCEED \$60,000; AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH THE SECOND LOWEST RESPONSIVE BIDDER IF THE FIRST LOWEST RESPONSIVE BIDDER DOES NOT MEET FILING OBLIGATIONS

WHEREAS, the FY20 Citywide Crack Seal Project (OM2001) (Project) will result in placement of crack sealant on various streets throughout the City; and

WHEREAS, the Project funding is included in the approved Fiscal Year 2018-23 Capital Improvement Program and funding is included in the adopted Operations and Maintenance budget for Fiscal Year 2019-20; and

WHEREAS, an invitation to bid was duly advertised on July 17, 2019, and July 24, 2019, and bids were opened on August 8, 2019; and

WHEREAS, Global Road Sealing, Inc. was determined to be the responsible bidder submitting the lowest responsive bid; and

WHEREAS, Graham Contractors, Inc. was determined to be the responsible bidder submitting the second lowest responsive bid; and

WHEREAS, the Project is a project under California Environmental Quality Act (Section 21000 et seq. of the Public Resources Code, hereinafter referred to as CEQA), which requires that cities consider the environmental consequences of their actions before approving a project; and

WHEREAS, Section 15301 (Existing Facilities) of the State CEQA Guidelines (Chapter 3 of Division 6 of Title 14 of the California Code of Regulations) provides an exemption from CEQA for projects involving the minor alteration of existing public or private facilities when the alteration involves negligible or no expansion of an existing use. As this Project consists of repairs and maintenance to existing City facilities within existing City right-of-way and involves no expansion of use, it is the type of activity consistent with those allowed under CEQA Exemption 15301(c). No further environmental review is required to support the Project; and


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Finds the Project exempt from CEQA pursuant to pursuant to section 15301 of the State CEQA Guidelines and approves the Project; and
- 2) Authorizes the City Manager to execute a construction contract with Global Road Sealing, Inc. for the FY20 Citywide Crack Seal Project (OM2001) in the

amount of \$603,342 upon receipt of all required bonds and insurance and the approval of such bonds and insurance by the City Attorney; and,

- 3) Authorizes the City Engineer to approve change orders not-to-exceed \$60,000; and,
- 4) Authorizes the City Manager to execute a construction contract with the second lowest responsive and responsible bidder, Graham Contractors, Inc., if Global Road Sealing, Inc. does not meet filing obligations.
- 5) Directs that any project budget amount above the awarded amount for the construction contract and change orders, as well as any final project savings at project close out, will be released from the project budget and available for other operation and maintenance expenditures
