

RESOLUTION NO. 2019-257

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO ACCEPT AN APPROPRIATION FROM THE STATE SUPPLEMENTAL LAW ENFORCEMENT SERVICES FUND IN THE AMOUNT OF \$263,741, INCREASING THE POLICE DEPARTMENT'S REVENUE AND EXPENSE BUDGET BY THAT SAME AMOUNT, AND AMENDING POSITION CONTROL AND THE CITY-WIDE EMPLOYEE SALARY SCHEDULE BY ADDING A REAL TIME INFORMATION CENTER SUPERVISOR POSITION

WHEREAS, the State Legislature has recently authorized the release of supplemental funding for frontline law enforcement under the State Supplemental Law Enforcement Services Fund (SLESF) for FY 2019-2020; and

WHEREAS, the amount appropriated for the Elk Grove Police Department is \$263,741; and

WHEREAS, funds under this program must be used in accordance with Government Code 30061 and approved by Resolution; and

WHEREAS, the Police Department has determined an expenditure plan that supports police operations and services for the City of Elk Grove; and

WHEREAS, a portion of the expenditure plan allocates funds be used for the hiring of a Real Time Information Center (RTIC) supervisor; and

WHEREAS, the RTIC supervisor is a new position that will be covered by the General Fund once SLESF funding has been fully expended.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to:

- 1) accept an appropriation from the State Supplemental Law Enforcement Services Fund (SLESF) in the amount of \$263,741;
- 2) increase the Police Department's revenue and expense budget in the amount of a total amount of \$263,741 in the appropriate fiscal year for the life of the SLESF grant; and
- 3) expend funds in accordance with Government code Section 30061; and
- 4) amend Position Control and the City-Wide Employee Salary Schedule by adding a Real Time Information Center supervisor position at the below salary range.
