

**RESOLUTION NO. 2019-273**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT FOR SERVICES  
BETWEEN VISIT ELK GROVE AND THE CITY OF ELK GROVE BY WHICH THE  
CITY WILL TEMPORARILY MANAGE THE DAY-TO-DAY PROGRAMS AND  
ACTIVITIES OF VISIT ELK GROVE**

**WHEREAS**, the goals of the City Council of the City of Elk Grove include the support of Elk Grove's hoteliers and the development of Elk Grove as a visitation and hospitality destination; and

**WHEREAS**, given the importance of the City's Tourism Marketing District and the programs and activities of Visit Elk Grove in achieving the City Council's visitation and hospitality goals, the City of Elk Grove desires, and Visit Elk Grove desires, that City staff provide temporary management services of Visit Elk Grove's day-to-day programs and activities and that Visit Elk Grove compensate the City for services provided to date and services to be provided in the future all pursuant to the terms of the Contract for Services.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove authorizes the City Manager to execute a Contract for Services with Visit Elk Grove in substantially the form presented, by which the City will temporarily manage the day-to-day programs and activities of Visit Elk Grove.


