

RESOLUTION NO. 2020-035

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE ACCEPTING THE SHELDON ROAD AND WATERMAN ROAD LANDSCAPE AND IRRIGATION PHASE 2 (PT0138) AND GRANT LINE ROAD OVERCROSSING LANDSCAPING IMPROVEMENTS (WTR030) PROJECTS AS COMPLETE; AUTHORIZING THE CITY ENGINEER TO PREPARE AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE SACRAMENTO COUNTY RECORDER; AND AUTHORIZING STAFF TO AMEND THE ANNUAL BUDGET AND CAPITAL IMPROVEMENT PROGRAM BY REDUCING THE REMAINING PROJECT BUDGET AUTHORITY TO ZERO AND RETURNING ANY REMAINING FUNDS BACK TO THEIR RESPECTIVE FUND(S)

WHEREAS, on September 12, 2018, the City Council authorized the award of a construction contract to Marina Landscape, Inc., for the Sheldon Road and Waterman Road Landscape and Irrigation Phase 2 (PT0138) and Grant Line Road Overcrossing Landscaping Improvements (WTR030) Projects (Project); and

WHEREAS, the Sheldon Road and Waterman Road Landscape and Irrigation Phase 2 (PT0138) Project (Roundabout Landscaping) included the landscaping and irrigation at the Sheldon/Waterman Roundabout and included drilling and development of an irrigation well, including underground storage tank, pumps and well controls; and

WHEREAS, the Grant Line Road Overcrossing Landscaping Improvements (WTR030) Project (Overcrossing Landscaping) included approximately three acres of landscaping improvements on the south side embankments of the Grant Line Road overcrossing over the Union Pacific Railroad (UPRR), including testing and repair of the existing irrigation system at this location; and

WHEREAS, Marina Landscape, Inc. has completed the work in accordance with the terms and conditions of the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Marina Landscape, Inc.; and


WHEREAS, post construction work is typically completed within 120 days of the City Clerk filing the Notice of Completion with the Sacramento County Recorder and then all invoices can be paid.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Accepts the Sheldon Road and Waterman Road Landscape and Irrigation Phase 2 (PT0138) and Grant Line Road Overcrossing Landscaping Improvements (WTR030) Projects as complete;
- 2) Authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder; and


- 3) Authorizes staff to amend the Annual Budget and Capital Improvement Program by reducing the remaining project budget authority to zero and returning any remaining funds back to their respective fund(s).
