A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE CONTRACTS WITH AZTECA SYSTEMS, LLC (CITYWORKS) IN THE AMOUNT OF \$238,125 AND WITH TIMMONS GROUP, INC. IN THE AMOUNT OF UP TO \$269,627.50 FOR THE PURCHASE AND INSTALLATION OF A COMPUTERIZED MAINTENANCE MANAGEMENT SYSTEM FOR THE PUBLIC WORKS OPERATIONS AND MAINTENANCE DIVISION FOR A TOTAL THREE-YEAR NOT-TO-EXCEED AMOUNT OF \$507,752.50

WHEREAS, staff solicited and received proposals for a Computerized Maintenance Management System software, and proposals from consultants for implementation utilizing the City's current Geographic Information System (GIS); and

WHEREAS, staff reviewed all proposals and found that Cityworks, a GIS-centric Computerized Maintenance Management System software solution, offered through Azteca Systems, LLC, best meets the key requirements of the Request for Proposals; and

WHEREAS, Timmons Group, Inc. is a platinum implementation partner with Azteca Systems, LLC, for the installation and implementation of the Cityworks software solution; and

WHEREAS, Timmons Group, Inc. offers elective Ancillary Services, which the Public Works Director has the authority to authorize the services by written consent; and

WHEREAS, sufficient funding is identified in the Public Works Department, Operations and Maintenance Division Fiscal Year 2019-20 operating budget for the initial licensing and maintenance of the Cityworks software, and for installation and implementation of Cityworks by Timmons Group, Inc.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- Authorizes the City Manager to execute a contract with Azteca Systems, LLC, in substantially the form presented, for the licensing and maintenance of the Cityworks software for a three year period, at a cost of \$69,375 in Year 1; \$79,357 in Year 2; and \$89,375 in Year 3, for a total not-to-exceed amount of \$238,125; and
- 2) Authorizes the City Manager to execute a contract with Timmons Group, Inc., in substantially the form presented, for the installation and implementation of the Cityworks software in the amount of \$207,867.50, with Ancillary Services tasks in the amount of \$61,760, for a total not-to exceed amount of \$269,627.50.

AND BE IT FURTHER RESOLVED that the Public Works Director shall have authority to approve the purchase of Ancillary Services (as defined in the Agreement) in an amount not to exceed \$61,760.
