

RESOLUTION NO. 2020-121

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH THE COMPETITIVE BIDDING PROCESS PURSUANT TO ELK
GROVE MUNICIPAL CODE 3.42 AND AUTHORIZING THE CITY MANAGER TO
EXECUTE AN AGREEMENT WITH DELL MARKETING, L.P. FOR THE PURCHASE
OF REPLACEMENT POLICE MOBILE COMPUTERS FOR A TOTAL AMOUNT NOT-
TO-EXCEED \$203,450.48 THROUGH A COOPERATIVE PURCHASING
AGREEMENT**

WHEREAS, Elk Grove police officers are required to use mobile computers to support their work in the community; and

WHEREAS, the mobile computers currently used by officers are on a three-year replacement plan and have exceeded their life expectancy; and

WHEREAS, replacing existing mobile computers with Dell products allows the department to utilize existing Dell hardware installed in department vehicles; and

WHEREAS, pursuant to Elk Grove Municipal Code Chapter 3.42, the City Council may dispense with the competitive bidding process when the purchase is processed through a cooperative purchasing agreement; and

WHEREAS, the Minnesota Western States Contracting Alliance (WSCA)-NASPO has secured competitive pricing for this commodity and the City of Elk Grove may take advantage of this pricing.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the competitive bidding process pursuant to EGMC Sections 3.42.180(B)(4) and 3.42.220, and authorizes the City Manager to execute an agreement with Dell Marketing, L.P., in substantially the form presented, for the purchase of police mobile computers for a total amount not-to-exceed \$203,450.48.
