

**RESOLUTION NO. 2020-228**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO A  
CONTRACT WITH AECOM TECHNICAL SERVICES, INC. FOR THE MULTI-SPORT  
COMPLEX AND SOUTHEAST INDUSTRIAL ANNEXATION AREA PROJECT,  
AMENDING THE CONTRACT BY \$38,464 FOR A TOTAL CONTRACT VALUE  
OF \$88,389**

**WHEREAS**, the City entered into Contract C-20-267 (the Contract) with AECOM Technical Services, Inc. (Consultant) for preparation of a Supplemental Environmental Impact Report (SEIR) for the Multi-Sport Complex and Southeast Industrial Annexation Area Project (the Project); and

**WHEREAS**, additional services from Consultant are necessary to complete the SEIR; and

**WHEREAS**, several mitigation measures from the 2019 EIR need to be completed prior to consideration of the annexation application by the Sacramento Local Agency Formation Commission.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute an amendment to the contract with AECOM Technical Services, Inc., in substantially the form presented, to add the services identified and increasing the budget by \$38,464, for a total contract value of \$88,389.
