## **RESOLUTION NO. 2021-046**

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH FORMAL PROPOSAL PROCEDURES PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.188(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE A GENERAL SERVICES CONTRACT WITH THE SIGN CENTER FOR ON-SITE PROJECT NOTICING AND SIGNAGE SERVICES

WHEREAS, staff has identified the need to have additional resources available to assist with on-site project noticing and signage services including sign manufacturing, sign posting and installation, sign maintenance, and sign removal for development projects, which are necessary for both private development projects and advanced planning efforts; and

**WHEREAS**, Section 3.42.188(B)(3) of the Elk Grove Municipal Code allows the City Council to dispense with the formal proposal procedure when it determines that this procedure is not in the best interest of the City; and

**WHEREAS**, The Sign Center has previously qualified for and was awarded a contract through the City's formal proposal procedures based on their expertise, local knowledge, and competitive rates; and

**WHEREAS**, The Sign Center has previously completed tasks and/or fulfilled contracts to the satisfaction of the City related to on-site project noticing and signage services; and

WHEREAS, The Sign Center has previously completed tasks and/or fulfilled contracts to the satisfaction of the City related to Current and Long-Range Strategic Planning; and

**WHEREAS**, The Sign Center, through prior work and the current contract, has become familiar with the City's sign requirements which will allow them to perform future tasks efficiently; and

**WHEREAS**, for the reasons presented, staff recommends dispensing with the formal competitive proposal process for the proposed contract with The Sign Center; and

**WHEREAS**, work under the proposed general services contract will be authorized through invoices, approved by the Development Services Director, the Planning Manager, or authorized designee, which include the scope of work, not-toexceed cost for services, and a schedule for completion of the specified work.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby dispenses with the formal proposal procedures pursuant to Elk Grove Municipal Code Section 3.42.188(B)(3) and authorizes the City Manager to execute a general services contract with The Sign Center, in substantially the form presented, for on-site project noticing and signage services in an amount not-to-exceed \$30,000 [for a total not-to-exceed amount of \$80,000].
