A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE COMPETITIVE BIDDING PROCESS PURSUANT TO ELK GROVE MUNICIPAL CODE 3.42.180(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE A THIRD AMENDMENT TO CONTRACT #C-13-380 WITH MIWALL CORPORATION FOR AMMUNITION IN THE AMOUNT OF \$450,000 FOR A TOTAL AMOUNT NOT-TO-EXCEED \$1,012,000

WHEREAS, the Elk Grove Police Department (EGPD) has 151 sworn officer positions which require the use of a firearm; and

WHEREAS, regular firearms training is required to maintain shooting proficiency and safety; and

WHEREAS, the EGPD must maintain a supply of ammunition for officer training, qualification, and duty purposes; and

WHEREAS, in 2013 staff conducted a competitive bid process to find an ammunition supplier that offered the best pricing and awarded a contract to Miwall Corporation (Miwall); and

WHEREAS, Miwall is the sole provider of Hornady Law Enforcement ammunition, the preferred ammunition for EGPD, in the State of California; and

WHEREAS, Miwall is a local corporation that has demonstrated its ability to provide speciality ammunition without delay, provides training ammunition at half off, and maintains consistently low pricing; and

WHEREAS, for the reasons presented, pursuing a formal competitive bidding process for ammunition is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the competitive process pursuant to EGMC 3.42.180(B)(3) and authorizes the City Manager to execute a third amendment to Contract #C-13-380 with Miwall Corporation for ammunition, in substantially the form presented, in the amount of \$450.000 for a total amount not-to-exceed \$1.012.000.
