

RESOLUTION NO. 2021-109

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A SECOND AMENDMENT TO
THE CONTRACT WITH AECOM TECHNICAL SERVICES, INC. FOR THE MULTI-
SPORT COMPLEX AND SOUTHEAST INDUSTRIAL ANNEXATION AREA
PROJECT, AMENDING THE CONTRACT BY \$10,000 FOR A TOTAL CONTRACT
VALUE OF \$98,389**

WHEREAS, the City entered into Contract No. C-20-267 (the Contract) with AECOM Technical Services, Inc. (Consultant) for preparation of a Supplemental Environmental Impact Report (SEIR) for the Multi-Sport Complex and Southeast Industrial Annexation Area Project (the Project); and

WHEREAS, the City and AECOM amended the contract in September 2020 (C-20-587); and

WHEREAS, additional services from Consultant are necessary to complete the SEIR; and

WHEREAS, several mitigation measures from the 2019 EIR need to be completed prior to consideration of the annexation application by the Sacramento Local Agency Formation Commission;

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute an amendment to Contract No. C-20-267 with AECOM, in substantially the form presented, adding the services identified and increasing the budget by \$10,000, for a total contract value of \$98,389.


