## **RESOLUTION NO. 2021-164**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AMENDING THE FISCAL YEAR 2020-21 BUDGET AND FISCAL YEAR 2020-21 THROUGH 2024-25 CAPITAL IMPROVEMENT PROGRAM IN THE AMOUNT OF \$28,200 AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN EMISSION REDUCTION CREDITS PURCHASE AND SALE AGREEMENT WITH ELEMENT MARKETS EMISSIONS, LLC IN THE SAME AMOUNT FOR THE GRANT LINE SOUTHEAST INDUSTRIAL AREA (NO FURTHER CEQA REVIEW REQUIRED)

- **WHEREAS**, on January 27, 2021, the City Council certified the Supplemental Environmental Impact Report (SEIR) for the Grant Line Southeast Industrial Area and approved a General Plan Amendment, Specific Plan, and Pre-zoning for the Grant Line Southeast Industrial Area (Project); and
- **WHEREAS**, Mitigation Measure 3.4-2 of that SEIR required the preparation of an Air Quality Mitigation Plan (AQMP) that achieved a reduction in source operational ozone precursor emissions by at least 35 percent compared to an unmitigated project; and
- **WHEREAS**, the City has prepared an AQMP, which was approved by the Sacramento Metropolitan Air Quality Management District (SMAQMD) on May 19, 2021; and
- **WHEREAS**, the AQMP requires the purchase of 0.65 tons of SMAQMD Reactive Organic Gases (ROG) Emission Reduction Credits (the "ERCs"); and
- **WHEREAS**, in consultation with SMAQMD, Element Markets Emissions, LLC was determined as the appropriate credit bank for acquisition of these credits.
- **NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby finds that no further environmental review is required for the acquisition of the credits pursuant to State CEQA Guidelines Section 15162 because the purchase is consistent with the previously prepared SEIR as the credits implement Mitigation Measure 3.4-2.
- **AND, BE IT FURTHER RESOLVED**, that the City Council of the City of Elk Grove hereby amends the 2020-21 Fiscal Year (FY) Budget and FY 2020-21 through 2024-25 Capital Improvement Program by adding \$28,200 to the Project budget (1064120-5456606/WFC004106-5456606) from the General Capital Reserve Fund (Fund 106) fund balance.
- **AND, BE IT FURTHER RESOLVED**, that the City Manager is hereby authorized to execute the Emission Reduction Credits Purchase and Sale Agreement with Element Markets Emissions, LLC in the amount of \$28,200, in substantially the form presented, for the purchase of 0.65 tons of SMAQMD ROG Emission Reduction Credits.
