A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A CREDIT REIMBURSEMENT
AGREEMENT FOR SOUTHEAST POLICY AREA PARKLAND DEDICATION WITH
KRM INVESTORS, LLC, A CALIFORNIA LIMITED LIABILITY COMPANY, FOR
PUBLIC LAND DEDICATED TO THE CITY IN FEE TITLE THROUGH THE MENDES
APPROVED FINAL MAP (SUBDIVISION NO. 20-002); FINDING THAT THE
DEDICATION OF THE MENDES PARK SITE TO THE COSUMNES COMMUNITY
SERVICES DISTRICT IS CONSISTENT WITH THE GENERAL PLAN PURSUANT TO
GOVERNMENT CODE SECTION 65402; AND AUTHORIZING THE CITY MANAGER
TO EXECUTE AN IRREVOCABLE OFFER OF DEDICATION FOR THE MENDES
PARK SITE TO THE COSUMNES COMMUNITY SERVICES DISTRICT

WHEREAS, Elk Grove General Plan Policy PT-1-3, SEPA Community Plan Policy 7-2, Elk Grove Municipal Code Chapter 22.40 ("Chapter 22.40"), and state law provide for the dedication of parkland within new development at a rate of 5 acres per 1,000 residents; and

WHEREAS, Chapter 22.40 provides for credit or reimbursement to developers for land dedications in excess of the requirements based upon the subject subdivision, subject to approval by the City and Cosumnes Community Services District (CCSD) and entering into a reimbursement agreement with the City; and

WHEREAS, KRM Investors, LLC, a California limited liability, as a condition of development, is required to dedicate lands to the City of Elk Grove within the Southeast Policy Area (SEPA) that are eligible for reimbursement under the General Plan, SEPA Community Plan, and Chapter 22.40 as eligible for reimbursement; and

WHEREAS, following the City's receipt of dedicated lands, the City intends to transfer ownership of 9.3 acres of such parkland to the CCSD pursuant to the General Plan and Memorandum of Understanding between the City and CCSD.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a Credit Reimbursement Agreement with KRM Investors, LLC, in substantially the form presented, for reimbursement in the form of fee credits from the SEPA Park and Trail Fee Program for dedication of park land associated with the Mendes Subdivision Project located in the SEPA Special Planning Area, pursuant to Elk Grove Municipal Code Chapter 22.40.

AND, BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove finds that dedication of the park site to the CCSD is consistent with the General Plan pursuant to Government Code Section 65402 based upon the following finding:

<u>Finding:</u> The dedication of the Mendes Park Site to the CCSD is consistent with the City of Elk Grove General Plan.

<u>Evidence:</u> This dedication is consistent with the General Plan (as required by Government Code Section 65402 (Restrictions on Acquisition and Disposal of Real Property) because the site will be used for park purposes and is identified in the General Plan Land Use Map

for such purpose. Additionally, General Plan Goal PT-1 and corresponding policies call for the City and CCSD to collaboratively plan and develop park sites in growth areas. The Memorandum of Understanding between the City and CCSD provides that park sites in SEPA will be developed, owned, and maintained by the CCSD and that financing will be provided through City fee and finance district programs.

AND, BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute an Irrevocable Offer of Dedication for the Mendes Park Site to the Cosumnes Community Services District as described in the Credit Reimbursement Agreement with KRM Investors, LLC and as described in the approvals for the Mendes Subdivision Project (Subdivision No. 20-002).
