A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH COMPETITIVE BIDDING PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.188(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE A ONE-YEAR CONTRACT EXTENSION WITH SUPERION, LLC FOR CITYWIDE SOFTWARE PRODUCTS AND SERVICES IN AN AMOUNT NOT-TO-EXCEED \$347,125 [FOR A TOTAL CONTRACT AMOUNT NOT-TO-EXCEED \$7,428,937]

WHEREAS, in 2003 the City conducted a formal Request for Proposal for the purchase of Citywide software and SUPERION, LLC was awarded Contract No. C-03-145; and

WHEREAS, the City has used this software for 17 years as its Citywide software program to house centralized data that is accessed by over 300 staff members from every department; and

WHEREAS, the City has initiated an evaluation process with a consultant to ensure that best practices are being met and that the current software meets the needs of staff; and

WHEREAS; the one-year extension will allow the consultant time to complete the evaluation while maintaining continuity of business operations; and

WHEREAS, for the reasons provided, pursuing a formal request for proposal procedure for Citywide software at this time is not in the best interest of the City of Elk Grove; and

WHEREAS; the total cost for the one-year extension has been included in the Fiscal Year 2021-22 Budget for the Information Services Department.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the formal request for proposal procedure pursuant to Elk Grove Municipal Code Section 3.42.188(B)(3) and authorizes the City Manager to execute a one-year extension with SUPERION, LLC, in substantially the form presented, for Citywide software products and services in an amount not-to-exceed \$347,125, for a total contract amount not-to-exceed \$7,428,937.
