## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURE PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.140(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH SELECTRON TECHNOLOGIES, INC. FOR INTEGRATED VOICE RESPONSE SYSTEM SOFTWARE LICENSING AND MAINTENANCE FOR A TERM OF SIX YEARS IN AN AMOUNT NOT TO EXCEED \$180,475

**WHEREAS**, the City's current Integrated Voice Response (IVR) system uses software provided by Selectron; and

**WHEREAS**, Selectron is the only IVR provider that integrates with the City's current Enterprise Resource Management software (Central Square); and

**WHEREAS**, Selectron software is cloud-based and can integrate with the City's new phone system platform increasing efficiencies, providing ease of use, and increasing accessibility to online building inspection scheduling; and

**WHEREAS**, pursuant to Elk Grove Municipal Code Section 3.42.140(B)(3), the City Council may dispense with the formal request for proposal procedure when, in the judgment of the City Council, compliance with the procedure is not in the best interest of the City; and

**WHEREAS**, for the reasons presented, pursuing a formal request for proposal procedure for the subject software licensing and services is not in the best interest of the City.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby dispenses with the formal request for proposal procedure pursuant to EGMC Section 3.42.140(B)(3) and authorizes the City Manager to execute a six-year agreement with Selectron Technologies, Inc., in substantially the form presented, for the purchase of Integrated Voice Response system software licensing and maintenance in an amount not to exceed \$180,475 over the term of the contract; and

**BE IT FURTHER RESOLVED** that the City Manager is authorized to approve annual price increases, if any, not exceeding 3 percent annually, as provided in the agreement.
