RESOLUTION NO. 2021-191

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE ADOPTING SOLID WASTE SERVICE RATES FOR FISCAL YEAR 2021-22

WHEREAS, pursuant to the Franchise Agreement for Solid Waste Collection Services between the City and Allied Waste Services of North America, LLC, a subsidiary of Republic Services, Inc. ("Republic Services"), Republic Services is entitled to an annual compensation adjustment to cover inflationary increases in the cost to provide service; and

WHEREAS, the City Council of the City of Elk Grove has an obligation to notify all affected property owners and ratepayers of an increase in the rates that will be charged by Republic Services for solid waste disposal services; and

WHEREAS, pursuant to the noticing requirements of Proposition 218 staff prepared and mailed a notice to all solid waste service customers and all residential property owners notifying them of the proposed rate increase and the public hearing to be held on June 23, 2021; and

WHEREAS, this notice was mailed during the last week of April 2021, which was more than 45 days prior to the noticed public hearing date; and

WHEREAS, the City of Elk Grove did not receive protests exceeding 50 percent of the total residential property owners that are subject to the rate increase and, therefore, there was no majority protest against the rate increase.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby adopts the Solid Waste Rates for FY 2021-22 effective July 1, 2021, attached hereto as Exhibit A and incorporated herein by reference.
