A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE ELK GROVE COMMUNITY AND SENIOR CENTER (WCC010)
PROJECT AS COMPLETE; AUTHORIZING THE CITY ENGINEER TO PREPARE
AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE
SACRAMENTO COUNTY RECORDER; AND AUTHORIZING STAFF TO AMEND
THE ANNUAL BUDGET AND CAPITAL IMPROVEMENT PROGRAM BY REDUCING
THE REMAINING PROJECT BUDGET AUTHORITY TO ZERO AND RETURNING
ANY REMAINING FUNDS BACK TO THEIR RESPECTIVE FUND(S)

**WHEREAS**, on February 14, 2018, the City Council authorized the award of a construction contract to Bobo Construction, Inc., for the Elk Grove Community and Senior Center (WCC010) Project; and

WHEREAS, the Project included a single-story building of approximately 32,178 gross square feet consisting of the following program components: a divisible community hall with space for 500 people in a dining configuration and 940 people in a lecture configuration, including a commercial kitchen and catering pantry; a conference/meeting room with space for approximately 20 people; a Senior Center wing that included enrichment and personal development space, creative and fine arts studio classrooms, multi-use classrooms, office and workspace, and lounge; a Veterans Hall that included a program room, storage areas, and work/office space; City staff office space and other support spaces (e.g., restrooms, lobbies, and similar); café with indoor and outdoor seating and outdoor patios with fire pits and seating areas; and

**WHEREAS**, Bobo Construction, Inc. has completed the work in accordance with the terms and conditions of the contract documents for the Project; and

**WHEREAS**, if no liens or claims have been filed within 35 days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Bobo Construction, Inc.; and

**WHEREAS**, post construction work is typically completed within 120 days of the City Clerk filing the Notice of Completion with the Sacramento County Recorder and then all invoices can be paid.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby:

- 1) Accepts the Elk Grove Community and Senior Center (WCC010) Project as complete;
- 2) Authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder; and
- 3) Authorizes staff to amend the Annual Budget and Capital Improvement Program by reducing the remaining project budget authority to zero and returning any remaining funds back to their respective fund(s).
