

**RESOLUTION NO. 2021-206**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS NOT-TO-  
EXCEED \$2,227,396 FOR THE GRANT LINE ROAD WIDENING PHASE 2 PROJECT  
(WTR002) (NO FURTHER CEQA REVIEW REQUIRED)**

**WHEREAS**, a construction contract was awarded to George Reed, Inc., on November 18, 2020, for the Grant Line Road Widening Phase 2 Project (Project); and

**WHEREAS**, the original change order amount authorized was \$1,651,247; and

**WHEREAS**, the FY2021-2026 Capital Improvement Program increased the Project budget by \$576,149; and

**WHEREAS**, landscaping and lighting improvements are now being included with the Project, and require a contract change order; and

**WHEREAS**, the City of Elk Grove (City) entered into an agreement with Sacramento County Water Agency (SCWA) for construction of water facility improvements concurrently with the Project, and SCWA has revised the design thus an additional change order is required; and

**WHEREAS**, the City Engineer change order authority must be increased to cover the costs of these change orders; and

**WHEREAS**, the Grant Line Road Widening Phase 2 Project (WTR002) is a project under the California Environmental Quality Act (Section 21000 et seq. of the Public Resources Code, hereinafter referred to as CEQA), which requires that cities consider the environmental consequences of their actions before approving a project; and

**WHEREAS**, the potential environmental impacts for the Grant Line Road Widening Project were adequately analyzed under CEQA and documented in the Initial Study/Mitigated Negative Declarations for the following projects:

- City of Elk Grove – Grant Line Road Widening Project (State Clearinghouse #2005102056); and
- Capital SouthEast Connector – B2 Project, (State Clearinghouse #2017032030); and

**WHEREAS**, no substantial changes are proposed to either project in regard to CEQA and there are no substantial changes in circumstances or new information that would require revisions to the respective MMRPs or IS/MNDs. Therefore, no further environmental review is required under CEQA for this action.


