A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE ALLOCATING FUNDS TO ELIGIBLE NONPROFIT ORGANIZATIONS THROUGH THE AMERICAN RESCUE PLAN ACT (ARPA) NONPROFIT GRANT PROGRAM

WHEREAS, the COVID-19 pandemic has had a significant negative financial effect on many of Elk Grove's nonprofit organizations, which have seen increased demand for services and/or a loss in revenue associated with shutdown and "stay at home" orders; and

WHEREAS, on July 28, 2021, the City Council established a budget for funding allocated to the City from the American Rescue Plan Act of 2021 (ARPA) Fiscal Recovery Funds package to include \$2,500,000 for nonprofit grants to assist those that have faced economic hardship resulting from or exacerbated by the COVID-19 public health emergency, or those that have created new programming to address needs of households disparately impacted by the pandemic and its economic effects; and

WHEREAS, on September 8, 2021, the City Council adopted the ARPA Nonprofit Grant Program ("Program") Guidelines, outlining eligibility requirements and an application and review process; and

WHEREAS, a Program application was publicly available from September 10 to October 3, 2021, and subsequently a review panel comprised of community members reviewed the eligible applications and made funding recommendations for consideration by the City Council.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby approves the allocation of ARPA funds designated for the Nonprofit Grant Program as shown in Exhibit A, attached hereto and incorporated herein by reference, and authorizes the City Manager to implement the funding awards in such amounts, subject to the Program guidelines and in accordance with state and federal requirements.
