NOTICE IS HEREBY GIVEN that on **Wednesday, June 14, 2023**, at the hour of **6:00 p.m.**, or as soon thereafter as the matter may be heard, the Elk Grove City Council will conduct a public hearing at City Hall in the Council Chambers, 8400 Laguna Palms Way, Elk Grove, California, to consider the following matter:

The Elk Grove City Council will conduct a public hearing to consider an increase to the residential solid waste service rates for FY 2023-24. If approved, these rate increases will take effect on July 1, 2023, and apply to all residential parcels located within the City of Elk Grove in accordance with Elk Grove Municipal Code Chapter 30.20.
